STORAGE AND MAINTENANCE

- STORE PRODUCTS IN A DRY, COOL, WELL-VENTILATED PLACE, AWAY FROM LIGHT, SUNLIGHT AND ULTRAVIOLET RAYS, AND IN THEIR ORIGINAL PACKAGING
- WHEN CORRECTLY STORED, GLOVES RETAIN THEIR PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE INSTRUCTIONS MUST BE ENCLOSED WITH THE SMALLEST PACKAGING
- BAG OF 10 PAIRS
- BOX OF 100 PAIRS
