STORAGE AND MAINTENANCE

- WHEN CORRECTLY STORED **GLOVES RETAIN THEIR** PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- **NOT WASHABLE**

PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE NOTICE MUST BE **ENCLOSED WITH THE SMALLEST PACKAGING**
- **BAG OF 10 PAIRS**
- **BOX OF 100 PAIRS**
