STORAGE AND MAINTENANCE

- WHEN CORRECTLY STORED, GLOVES RETAIN THEIR PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE LEAFLET MUST BE ENCLOSED WITH THE SMALLEST PACKAGING
- BAG OF 10 PAIRS
- BOX OF 100 PAIRS
