PRECAUTIONS FOR USE

- BEFORE RE-USE, CHECK GLOVES FOR DEFECTS, HOLES, TEARS, ABNORMAL WEAR, ETC

STORAGE AND MAINTENANCE

- STORE PRODUCTS IN A DRY, COOL, WELL-VENTILATED PLACE, AWAY FROM LIGHT, SUNLIGHT AND ULTRAVIOLET RAYS, AND IN THEIR ORIGINAL PACKAGING
- WHEN CORRECTLY STORED, **GLOVES RETAIN THEIR** PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE REQUIRED
- MACHINE WASHABLE ON 3 **CYCLES**

PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE NOTICE MUST BE **ENCLOSED WITH THE SMALLEST PACKAGING**
- **BAG OF 10 PAIRS**
- **BOX OF 100 PAIRS**
