STORAGE AND MAINTENANCE

- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

SAFETY, COMFORT, AND DEXTERITY

- DEXTERITY: LEVEL 5
- THIS GLOVE DOES NOT CONTAIN ANY SUBSTANCES AT LEVELS KNOWN OR SUSPECTED TO HAVE ADVERSE EFFECTS ON THE HYGIENE OR HEALTH OF THE USER UNDER THE EXPECTED CONDITIONS OF USE
