#### **PRECAUTIONS FOR USE**

# STORAGE AND MAINTENANCE

- STORE PRODUCTS IN A DRY, COOL, WELL-VENTILATED PLACE, AWAY FROM LIGHT, SUNLIGHT AND ULTRAVIOLET RAYS, AND IN THEIR ORIGINAL PACKAGING
- WHEN CORRECTLY STORED, **GLOVES RETAIN THEIR** PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

#### **PACKAGING**

- IN CASE OF DECONDITIONING, A COPY OF THE INSTRUCTIONS MUST BE ENCLOSED WITH THE SMALLEST **PACKAGING**
- **BAG OF 10 PAIRS**
- **BOX OF 100 PAIRS**
