STORAGE AND MAINTENANCE

- STORE PRODUCTS IN A DRY, COOL, WELL-VENTILATED PLACE, AWAY FROM LIGHT, SUNLIGHT AND ULTRAVIOLET RAYS, LEAVING THEM IN THEIR ORIGINAL PACKAGING
- WHEN CORRECTLY STORED, GLOVES RETAIN THEIR PROPERTIES WITHOUT UNDERGOING MAJOR CHANGES
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- WASHING INSTRUCTIONS UNDER ISO 6330: 3 DOMESTIC WASHING CYCLES 60°MAX



PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE NOTICE MUST BE ENCLOSED WITH THE SMALLEST PACKAGING
- BAG OF 10 PAIRS
- BOX OF 100 PAIRS
