PRECAUTIONS FOR USE

STORAGE AND MAINTENANCE

- STORE PRODUCTS IN A DRY, COOL, WELL-VENTILATED PLACE, AWAY FROM LIGHT, SUNLIGHT AND ULTRAVIOLET RAYS, AND IN THEIR ORIGINAL PACKAGING
- WHEN CORRECTLY STORED, GLOVES RETAIN THEIR PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

DISPOSAL

- END-OF-LIFE DESTRUCTION MUST BE CONTROLLED AND COMPLY WITH EUROPEAN TRACEABILITY AND ENVIRONMENTAL REQUIREMENTS

PACKAGING
