- WHEN CORRECTLY STORED, GLOVES RETAIN THEIR PROPERTIES WITHOUT UNDERGOING SIGNIFICANT CHANGE
- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

PACKAGING
