STORAGE AND MAINTENANCE

- NO SPECIAL MAINTENANCE IS RECOMMENDED
- NOT WASHABLE

PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE INSTRUCTIONS MUST BE ENCLOSED WITH THE SMALLEST PACKAGING
- BAG OF 10 PAIRS
- BOX OF 100 PAIRS
