- NOT WASHABLE

PACKAGING

- IN CASE OF DECONDITIONING, A COPY OF THE INSTRUCTIONS MUST BE ENCLOSED WITH THE SMALLEST **PACKAGING**
- **BAG OF 10 PAIRS**
- **BOX OF 100 PAIRS**
