STORAGE AND MAINTENANCE

- STORE PRODUCTS IN A DRY, COOL, WELL-VENTILATED PLACE, AWAY FROM LIGHT, SUNLIGHT AND ULTRAVIOLET RAYS, LEAVING THEM IN THEIR ORIGINAL PACKAGING
- WHEN STORED CORRECTLY, THE GLOVES RETAIN THEIR PROPERTIES WITHOUT UNDERGOING MAJOR CHANGES
- NO SPECIAL CARE IS RECOMMENDED
- NOT WASHABLE
